Overview of F5SMC Key Communications Tool – Using the Message Map to Develop Stories

#### **DEVELOPING STORIES**

In preparation for this agenda item, Commissioners and Staff should review the Message Map (See Attachment 3A) and write-up three stories that illustrate three different points on the map. The stories can be brief 3-6 sentences each, but they should provide a concrete example of that message point.

For example, for the message point that reads "We provide financial and technical support to evidence-based and promising programs in childhood health, early learning and family engagement," one story might say: "F5SMC continues to fund the Virtual Dental Home Program, which is a partnership with the Ravenswood Family Health Center. More than a thousand children in San Mateo County have been served by the Virtual Dental Home Model since 2012. It is on target to serve 600 children ages 1 through 5 this year in San Mateo County. This would not be possible without the funding that F5SMC provides."

The stories can be handwritten or typed, but please be aware that RSE will collect the stories at the end of the session to use in future projects.
