

## **Background**

- Literature has always been controversial but throughout 2020-2022 the country saw a wide spread banning of books often with diverse characters.
- This project is working to undo the harms of book banning, focusing and promoting the importance of diverse children's literature





## **Research/Statistics**

Children with low literacy rates are likely to receive poor grades, skip school, and exhibit behavioral issues.

- 1. According to the Children's Reading Foundation, 2 out of 10 children enter elementary school without proficiency in grade levels.
- 2. According to the NCES, 34% of students in the fourth grade lack a basic reading level.
- 3. Ethnicity is a factor. About 52% of Black fourth-grade children and 45% of Hispanic fourth graders score below basic reading levels, compared to 23% of white students, according to NCES assessments.
- 4. Cognitive processes develop rapidly in the first few years of life. In fact, by age 3, roughly 85% of the brain is developed. However, traditional education takes places in grades K-12, which begin at age five.

- 37% of the population of the United States are people of color, only
   10% of children's books published contained multicultural content (diversebooks.org)."


## FY22-23 Draft Budget - Key Take Aways







## Peninsula Family Service (PFS) Therapeutic Child Development Centers

Therapeutic treatment milieu - addressing toxic stress and trauma - for homeless toddlers and preschoolers (18+ mos) in an early learning setting at First Step for Families and Haven House.
