4. Commission Announcements:

Welcome Commissioner Colleen Chawla, new San Mateo County Health Chief

Colleen Chawla introduced herself as having previously served on the First 5 Commission in Alameda County. She has 20 years of experience working in local health departments such as Alameda and San Francisco counties.

5. Storytelling: First 5 Work/Impact:

Commissioner Hanish Rathod shared about his background in nonprofits and public policy, a field in which he has worked for the past 20 years where he has primarily focused on K-12. Most recently, he spent nine years serving on the board for First Graduate, a nonprofit organization focused on the goal of helping disadvantaged youth to be the first in their family to go to college. Starting in middle school, First Graduate provides these children and their families the necessary support to ensure the success of these students in getting through middle school, high school, and college. Hanish believes that education is the backbone of social mobility and has been inspired by the goal of First 5 in providing support to children as early as possible in life, namely the first five years, which he believes are crucial to the success of any child.

6. <u>Approval of First 5 San Mateo County's FY 24-25 Revised Budget and the Use of Ending Fund</u> Balance (Ending Reserves*) to Fund FY 2024 – 2025 Revised Budget

Kitty Lopez, F5SMC's Executive Director, shared info on this agenda item and highlighted that the following:

- The Finance and Administration Committee reviewed and endorsed the approval of the FY 2024 – 25 Revised Budget and the use of Ending Fund Balance at its Committee meeting on February 3, 2025
- F5SMC considers the fund balance as "committed dollars" which are indispensable in funding community investments, and to be viewed as more than just "extra money"
- The fund balance will be part of F5SMC's long term financial plan, being spread out over the course of five years,
- The tobacco tax is insufficient to fund the projects of F5SMC due to its ongoing decline, averaging a yearly 6% decrease, recent higher declines have been due to the Prop 31 flavor ban
- 17% increase in total revenues resulting from Higher Interest and Tobacco Tax Revenues, and inclusion of Baby Bonus Program Other Grant Revenue.
- 22% decrease in funds, highlighting the necessity of the commission's approval to make the
 ending reserves available to enable F5SMC to fund their community investments and to
 continue to honor their contracts with grantees

- The funding for this Agreement and increased amount which comes from a grant awarded to F5SMC from First 5 California and F5 San Benito Region 4 IMAPCT Hub Lead and is pass though funding to the SMCOE to provide administration of and training for the Young Boys of Color community of practice.
- The YBOC runs February 2025 through May 2025. (See Attachment 8.1) For SMC specifically, the training supports 40 participants, 3 subject matter trainers/experts and 12 coaches for 1:1 follow-up connection with COP participants
- To provide training on equity practices
- to support the learning around quality education, to support black boys and other boys of color
- to fund a book study based on research, followed by individual coaching for teacher participants and a community of practice.

STRATEGIC INVESTMENT FOCUS AREAS – UPDATE

QUALITY CARE AND EDUCATION

Child Care Partnership Council (CCPC)

On March 17th the Child Care Partnership Council (CCPC) met for its monthly meeting. First, Sarah Kinahan, a consultant, presented on the 2024-25 Child Care Zip Code Priorities. This annual mandate identifies local priorities for the allocation of new state funding to ensure equitable access to child development services. A key finding was the significant gap in subsidized care for infants and toddlers, with 88% of infants and toddlers in need not being served, representing the largest gap in care across all age groups.

Karen Pace, CEO of the Ravenswood Early Childhood Collaborative, spoke about a new initiative aimed at providing high-quality education and care for children ages 0-5 in the Ravenswood community, a high-priority zip code. Funded by parcel tax revenue, this initiative will provide over \$2 million annually to support families and child care providers, including community navigators and a digital platform for providers. Lastly, Board of Supervisor Jackie Speier, co-chair of the CCPC, challenged attendees to envision what could be done with additional funding from potential sales tax revenue to further support child care and providers in the county echoing a long held & desired strategy of child care and children advocates.

HEALTHY CHILDREN

Child-Parent Psychotherapy Training

First 5 SMC will launch the third and final cohort of Child-Parent Psychotherapy training for mental health clinicians on March 26. The training, which is conducted by UCSF Child Trauma Research Project staff member Dr. Vilma Reyes, is funded as part of a Children and Youth Behavioral Health Initiative grant F5SMC received last year to support the training of up to 50 mental health clinicians locally in an evidence-based early childhood mental health practice for child-caregiver dyads. With the launch of this training, F5SMC will have exceeded that goal with 55 clinicians currently enrolled in training through three cohorts.

RESILIENT FAMILIES

Big Lift Family Engagement Shared Learning Collaborative

On March 14th, Jenifer Clark attended the Big Lift's Shared Learning Collaborative for family engagement professionals who support children and their families in the Big Lift early learning programs. This group meets quarterly and provides a space for family advocates, family navigators, home visitors, and others who provide support outside of the classroom setting to share resources, best practices, and concrete ideas for meeting families' needs and increasing authentic engagement with and among the families in their programs.



SPECIAL PROJECT

Baby Bonus Pilot Program

F5SMC anticipates enrolling families into the Baby Bonus pilot program starting the week of March 24th. Our implementation partners at Health Plan of San Mateo (HPSM) and Stanford will begin reaching out to eligible Medi-Cal families with newborn babies, and inviting them to sign up for monthly Baby Bonus payments through our partner UpTogether. The Baby Bonus payment is \$300 per month for 36 months. Some families will also be connected to a Community Health Worker from HPSM, who can help them access health care services and other family resources. On March 6th, the San Mateo County Prevention Abuse Council (CAPC) held its monthly meeting, which featured a presentation on the SMC Child Welfare Referral Data and plans for the 2025 Child Abuse Prevention Month activities. The data, once categorized for children aged 0-5, will help F5 in supporting public education and awareness initiatives aligned with the CAPC's new strategic plan, focused on prevention. This year's theme is "Promote Protective Factors and Strengthening Families. "Activities planned for the month include: A Proclamation presentation by BOS Jackie Spier; A Children's Memorial Flag raising; Distribution of Blue Ribbon Mints, Materials, and Pins (via www.partnersinprevention.org); Protective Factor Pocket Guides with the SMC CAPC logo and link (available in English and Spanish) and Connections to community events through CAPC partners (TBD).

Update on San Mateo County's Home Visiting System Coordination

San Mateo County's Home Visiting System Coordination is making great strides in

strengthening services for young children and their families. The initiative envisions a system that provides culturally and linguistically relevant support, nurtures parents, and reduces burdens on both families and providers.

Recently, an environmental scan and strategic planning process led by Tamara Hamai, President of Hamai Consulting, have helped us identify priorities, like expanding program eligibility and flexibility to improve access, improving quality, and strengthening continuity of care. We have set goals that include sharing a countywide definition of quality home visiting, sharing additional data from the environmental scan, and exploring strategies to support the well-being of home visiting practitioners.

Currently, 1,385 families (including 1,681 children and 1,331 parents) receive home visiting services in the county, with 1,400 home visits conducted weekly. Programs are supported by funding sources such as Head Start, First 5 San Mateo County, and Measure K, totaling \$10.8 million a year. Referrals come from schools, pediatricians, and clinics. With a focus on coordination, accessibility, and sustainability, San Mateo County's Home Visiting System continues to evolve to better serve families and build a strong foundation for young children's success.

FEBRUARY ANALYTICS OVERVIEW

In February, First 5 San Mateo County's social media efforts focused on celebrating Black History Month and topics related to child development, oral health, and immigration resources. The communications highlighted the contributions of Black caregivers and families, early childhood dental health, and community services. Posts highlighting Black caregivers, early childhood oral health, and local events saw the highest engagement, particularly on Facebook and Instagram.

Website traffic showed a slight increase from the previous period but was lower compared to the previous year, with the most-visited pages featuring diversity celebrations and parenting resources. Social media ads drove engagement, though overall ad performance declined slightly. Posts with visuals and community-focused content resonated most with audiences, reinforcing the importance of storytelling in outreach efforts.

Early Childhood Evaluation Advisory Committee Meeting - March 17, 2025

The Early Childhood Evaluation Advisory Committee met in person and via Zoom on Monday, March 17th.

Updates and Announcements:

- The group welcomed new Commissioners Colleen Chawla and Hanish Rathod to the subcommittee
- Because a quorum of Commissioners is required to be physically present at the inperson location, items requiring a vote were held over to our next meeting. These include:
 - o Electing a subcommittee chair for the 2025 calendar year;
 - Approving the minutes of the May 2024 Subcommittee meeting.

<u>Discussion: Ongoing Client-Level Data Collection for the remainder of FY 24-25 and during our New 2025-30 Strategic Plan</u>

The EVALCORP team presented a review of results from the 2024 Client Data Collection Pilot. The group then discussed options for collecting client-level data going forward. One goal for grantees in our upcoming 2025-30 funding cycle is to implement longitudinal data collection for clients seen for intensive one-on-one services over several months. We also plan to institute a survey of service providers who receive F5SMC-funded trainings or support, and to take steps to ensure higher survey completion rates for clients receiving less-intensive group-based services. Updated evaluation expectations will be included in the scopes of work for all organizations funded through our procurement processes related to the 2025-30 Strategic Plan. Given all of this, as well as a) the expectation that our current grantees will participate in the upcoming Partner Mapping Project, and b) the fact that many will also be participating in our procurements, the group recommended that we hold off on additional client-level data collection until new contracts start. This is more respectful of the time and effort grantees will be putting into the Partner Mapping Project and proposals for the new funding cycle. It also allows F5SMC to include clear expectations about evaluation and data collection in the contracts that will be executed as part of implementing the new Strategic Plan.

Update: Network Mapping with F5SMC Partner Organizations

This topic was held over due to time constraints.

The next meeting of the Early Childhood Evaluation Advisory Committee is scheduled to be held in person on May 12, 2025 from 3:30-4:30pm.
